## Open Forum/New Business:

Marsha Chappelow, DESE KC Charter Schools' Supervisor, was pleased to report KCIA is not a priority school (lowest 5%) this year. She commended the Board on KCIA's emphasis on culture, hiring effective teachers, and curriculum alignment. She is on the DESE charter renewal committee and felt good about the State Board approving KCIA's charter renewal.

### Finance Report:

Paul Greenwood reviewed the December monthly financial reports

# Superintendent's Report:

- Jennifer Wilson explained how MAP results and other factors are used in the APR calculation. Bruce Hensel with Informed Improvement shared a PowerPoint of KClA's data, noting a sizable increase in APR score from 38.1% in 2017 to 66.7% in 2018. The final APR will be made public on February 1, 2019.
- Dr. Fleming said School Smart KC has engaged Attuned Education Partners to conduct an internal audit on February 4, 2019 to assess needs. School Smart KC is a group that offers financial support to charters to help eliminate the achievement gap. They have already given \$75,000 for math curriculum and ANet membership and have indicated they want to get more involved with KCIA.

- Dr. Fleming noted KCIA's charter renewal application will go before the State Board on March 26, 2019.
- Dr. Fleming shared the current personnel report appointments and resignations.

Motion by Pat Johnston to approve the personnel report as presented. Ramsey Atieh seconded. Motion carried unanimously.

- Jennifer Wilson reported on attendance and enrollment current enrollment is 631; postcards have been sent out for FY20 enrollment.
- Hannah VanAusdal gave updates for middle and elementary schools. The middle school counselor has set up high school visits for 8th graders. Seven high schools have come to KCIA to talk with 8th graders. Six students have applied for and qualified to attend Lincoln Prep, a first for KCIA. A five week after school girls' basketball program began this week. At the elementary level, ACCESS testing began last week for EL students. During GROW meetings, teachers viewed and reflected on videos taken by colleagues of them teaching lesson plans.

• Hal Havens said projects are essentially done. For the soccer field/basketball court project, the sidewalk at the street still needs to be completed and the sewer issue is still not resolved.
